

Terms and Conditions

(Booking form on next page)

1. Reservations will be effective upon receipt of the booking contract duly completed with a 25% deposit of the total stay for a week or more and 50% for short stays.

Confirmation of your booking will be made by email, only real evidence of your stay.

Only persons listed on the booking voucher will stay in the rental.

2. Delay and early departure:

In the absence of a phone call stating late arrival, accommodation becomes available for rental 12h after your planned arrival date.

Early departure or late arrival will not result in a refund.

3. Cancellation of stay. :

The full deposit will be refunded by the campsite more than 30 days before the date of stay.

Less than 30 days before the arrival date the deposit will be retained by the campsite.

In the event of cancellation, the administration fees are non-refundable.

4. Your arrival and departure:

Check-in from 15:00 and check out before 11:00 for mobile homes and caravans rented. Arrival from 12:00 and departures before 12:00 for campsites.

Every day started is due.

Any excess will result in invoicing for an additional day.

5. Deposit and refund of rent

A deposit in the amount of € 200 will be requested on the day of arrival and will be refunded after an inventory of the mobile home made on the day of your departure and after establishing the conformity of the latter to the state primitive places. Otherwise, it will make a deduction of rehabilitation places and the value of missing or damaged equipment.

6. A sum of € 60 will be deducted from the amount of the deposit in case the rented accommodation has not been cleaned.

7. The rentals are non- smoking.

8. Pets are not allowed inside rentals.

9. Payment:

25% deposit on booking in accordance with the regulations. Remaining balance on arrival day.

10. The administrative costs amount to €12 per rental. They are free for pitch of campsite. In the event of cancellation, costs are non-refundable.
